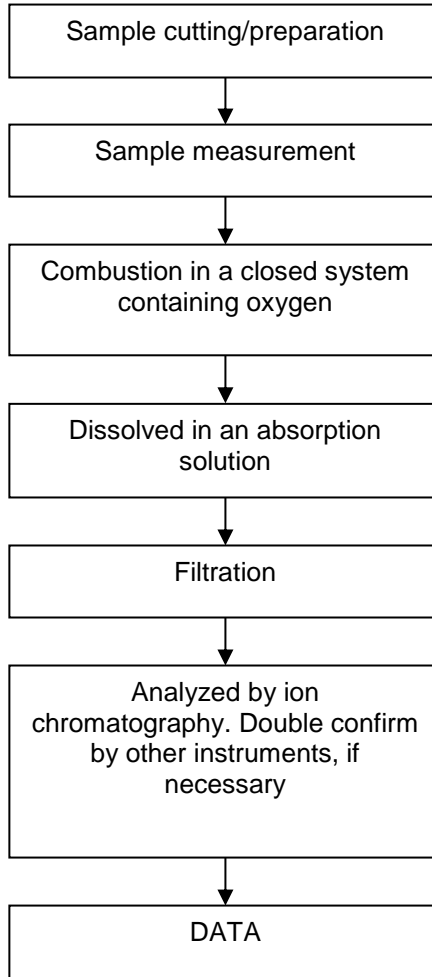

Halogen Testing Flow Chart



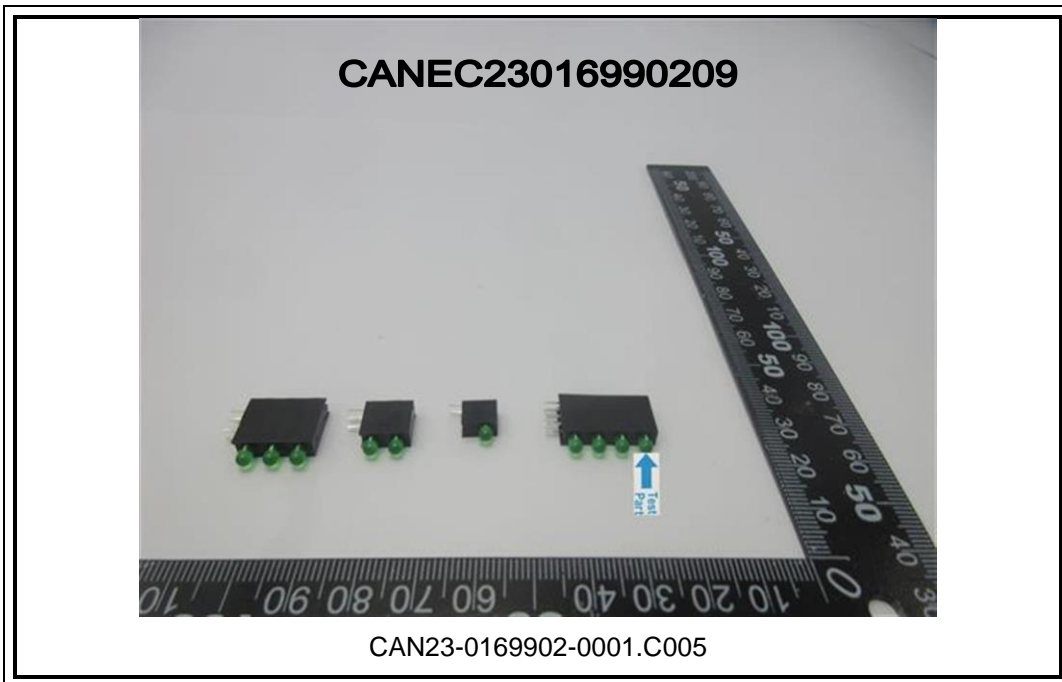
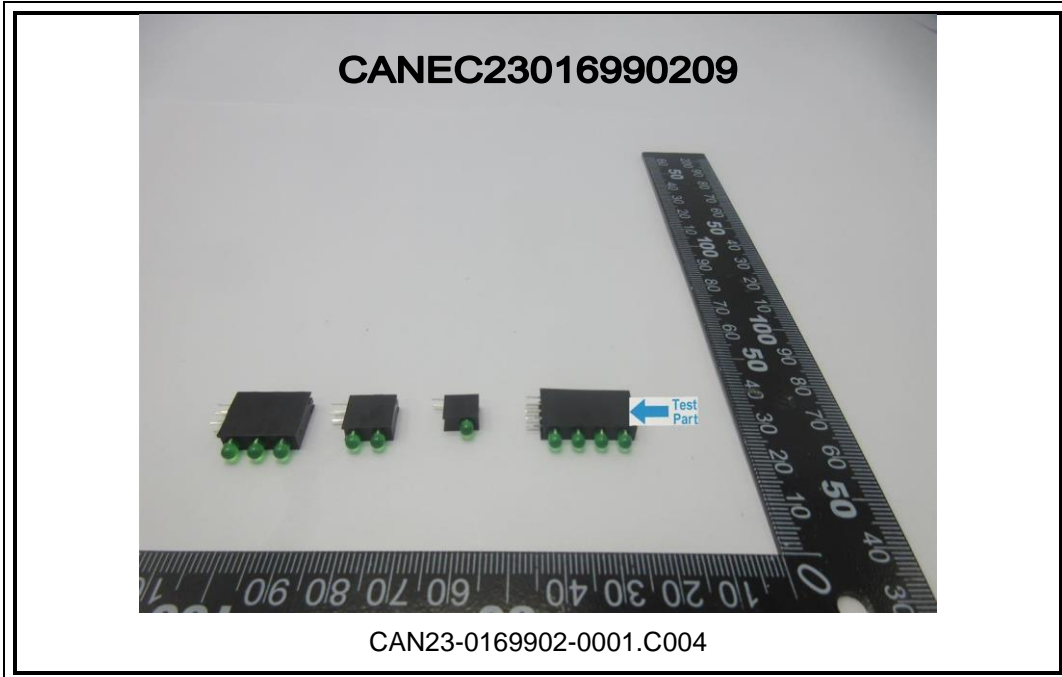
