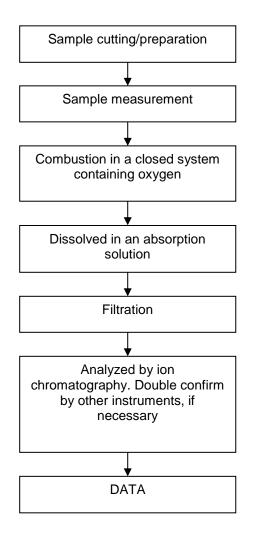

Halogen Testing Flow Chart




