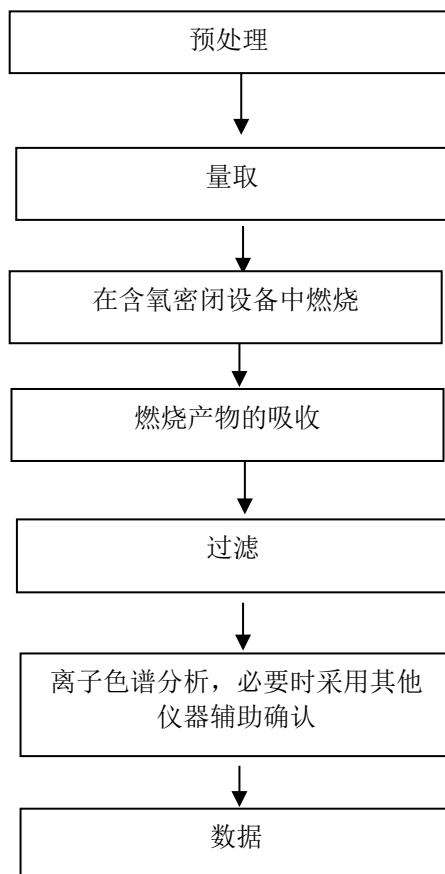

卤素检测流程图



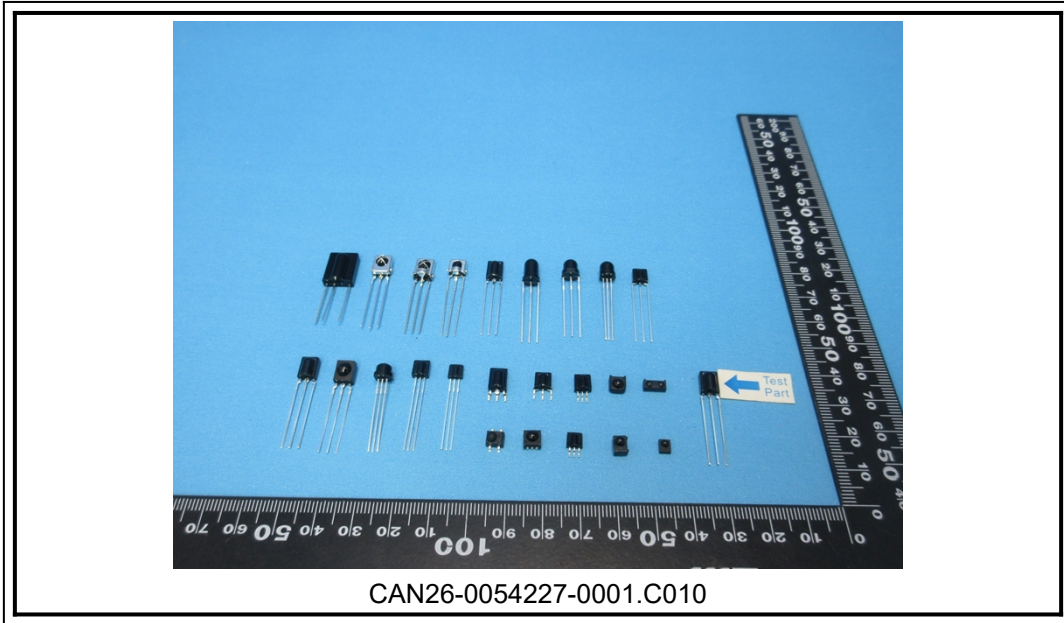
