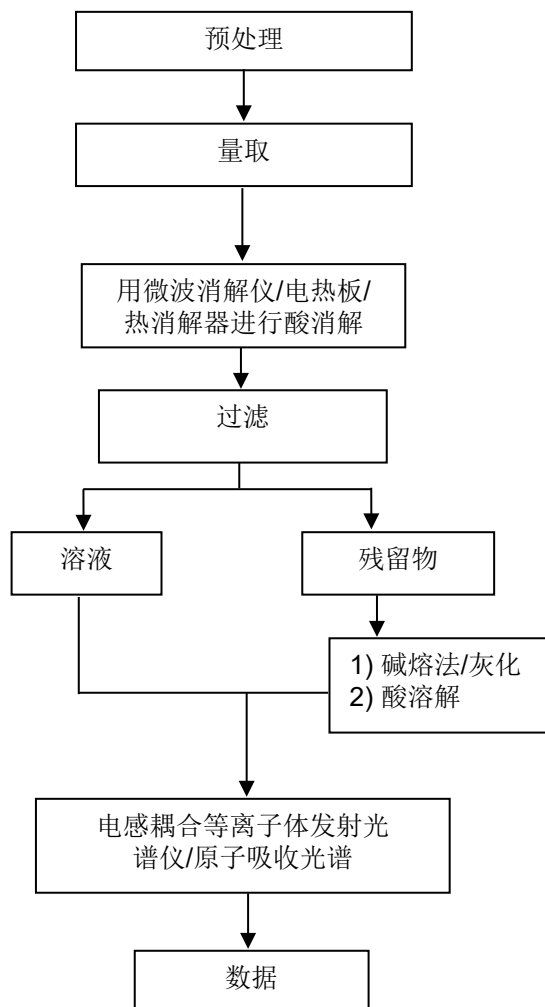

### 元素检测流程图

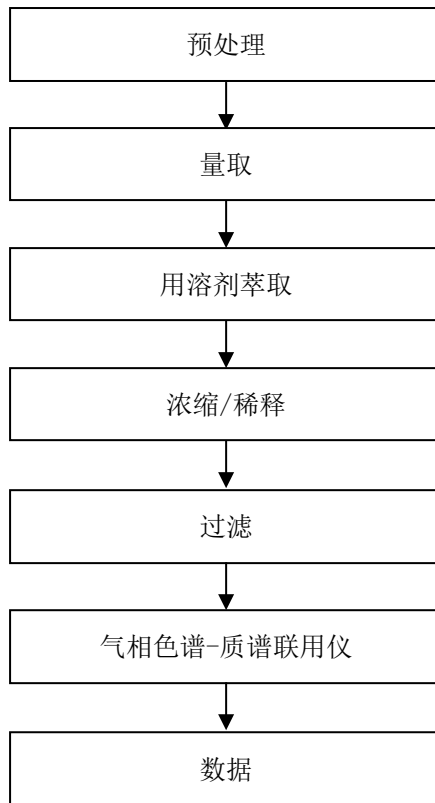
样品中的 Pb/Cd/Hg 按照下述流程被完全消解。

### PBB(s)/PBDE(s)/Phthalates 检测流程图



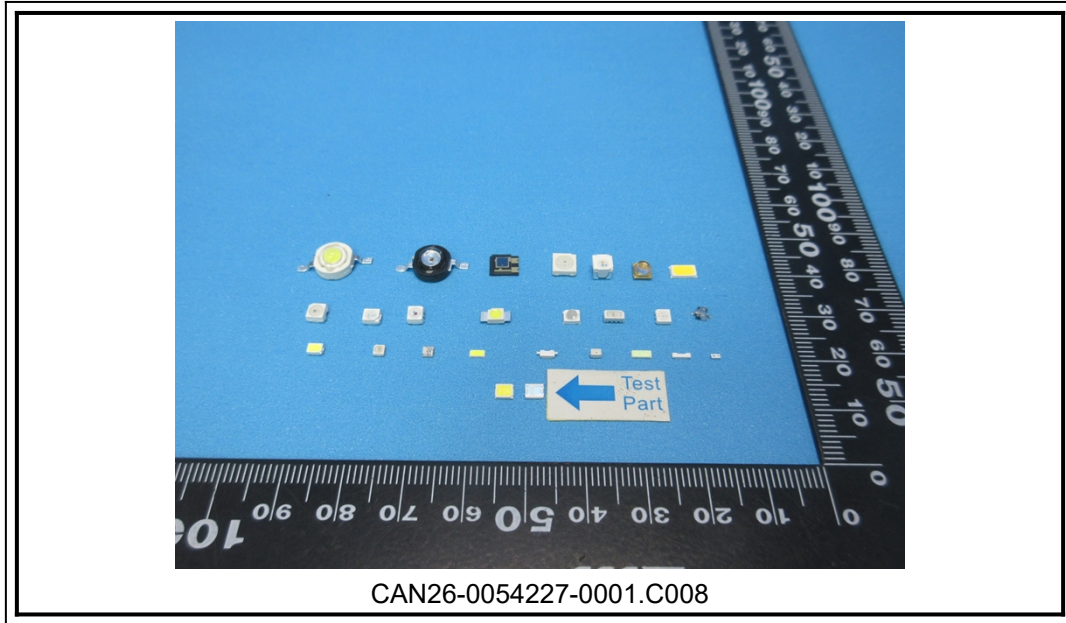
